### Upcoming Class Action Settlement Opportunities

Our agreement with Class Action Capital offers our members the opportunity to recover refunds from over a billion dollars per year in class action settlements. This is not participation in a lawsuit; it is submitting and managing a confidential claim to obtain a share of settlements that have already been approved for distribution. There is no upfront cost to participate in this program. The following are current and upcoming settlements that your facility may be eligible for:

- Lithium Ion Battery Settlement (\$64,500,000) will reimburse any company that purchased products containing lithium ion batteries, including laptops, camcorders, mobile phones and cordless power tools from 2000 through 2011. **This deadline is July 18, 2018.**
- Saline Solution Settlement (No settlement yet) will reimburse all entities in the United States that directly purchased intravenous saline solutions from the defendants since 2013. The defendants include: Baxter International, Inc., Baxter Healthcare Corporation, Hospira, Inc., and Hospira Worldwide, Inc.
- Blood Reagents Settlement (\$22,000,000) will reimburse any company that purchased traditional blood reagents in the United States directly from either of the defendants, Ortho or Immucor, during the period November 4, 2000 through October 19, 2015.
