The Administrator for the VISA and/or MasterCard credit or debit card settlement started sending mailers on March 25, 2019 to approximately twenty million potential claimants. The notices will likely contain the following dates, as well as information on how to proceed if a claimant would like to participate.

January 1, 2004 – January 25, 2019

Opt-Out Deadline:

July 23, 2019

November 7, 2019
